Dear Mr. Winegrad

On Friday, April 20, 1979, the University of Michigan Board of Regents voted 5-3 not to sell stock in two firms that have failed to endorse a widely accepted guideline for U.S. companies doing business in South Africa.

By voting to maintain investments in companies which refuse to say they actively oppose racial discrimination, the Board is insulting every citizen of this state.

A year ago this same board asked every company in which it invests to publicly disclose corporate progress towards achievement in affirmative action and equal pay for equal work, and to affirm the Sullivan principles which pledge opposition to racial discrimination.

The Sullivan principles, named after General Motors director the Rev. Leon Sullivan, call for desegregation at work, equal pay and upgrading the status of blacks in South Africa.

As a black citizen of this state I am appalled that a public institution is investing even one dime in companies that, in effect, condone the racist government policies of South Africa.

I think it is unreasonable to expect the University of Michigan to divest itself of stocks in companies that do business in South Africa no matter how reprehensible the government of that nation is to the American people. But it is more than reasonable to withdraw the financial support of this public institution from any company which gives tacit approval to the racist policies of South Africa.

Page 2 April 24, 1979

As a member of the Appropriations Subcommittee on Higher Education, I will be a resounding "No" vote on the budget for the University of Michigan.

I am requesting you and your organization to join with me and the members of the Michigan Legislative Black Caucus in attempting to have the University of Michigan Board of Regents rescind its decision and sell the University's holdings in both Black & Decker Manufacturing Co. and G.D. Searle and Co.
